### Imsys AB: Interim Report for 3rd Quarter, 9 months in financial year 2021-22

# The third quarter of the financial year 1 November 2021 - 31 January 2022 marks a high pace in the business.

The company's cost development and results for the third quarter and first nine months for the financial year 2021-22, compared with the same period last year, indicate that the development teams have grown in line with planned expansion. Invoicing is still negatively affected by the pandemic.

## For the third quarter of the financial year, Imsys reports the following results (compared with 3<sup>rd</sup> Quarter 2020-21) in Thousand SEK:

- Sales amounted to 11 KSEK (242 TSEK)
- Profit after financial items amounted to 3,466 TSEK (- 3,150 TSEK)
- Investments in development work amounted to 2,921 TSEK (2,258 TSEK)
- The gross margin on product sales amounted to 62.5% (67.8%)
- Earnings in kronor per share amounted to 0.22 (-0.23)
