Eyeonid Group AB (publ) signs letter of intent with Abelco regarding cooperation in Southeast Asia

Eyeonid Group AB (publ) have today signed a letter of intent with Abelco Investment Group AB (publ) regarding Eyeonid's products and services for the Southeast Asian markets. The parties' ambition is to jointly explore possibilities to establish sales- and marketing presence for Eyeonid in the local markets within the region, where Abelco holds a strong position resource wise through its' fully owned Fatfish Group.

Eyeonid Group AB (publ) ("EyeOnID") has entered into a letter of intent ("LOI") with Abelco Investment Group AB (publ) ("Abelco") regarding a potential commercial cooperation agreement. The parties' ambition is to explore potential opportunities and terms for such a commercial cooperation agreement, where EyeOnID's products and services combined with Abelco's presence in Southeast Asia marks the foundation for such discussions.
