WHAT YOU NEED TO DO:

1. EXPRESS YOUR INTEREST TO MTI

Let us know at the earliest if you would like to participate.

2. BOOK FLIGHTS

- Flight to Mombasa (MBA) arriving on Saturday, January the 13th or on Sunday, January the 14th.
- Return flight from Mombasa on Wednesday, January 17th late afternoon/evening or at your own discretion

3. APPLY FOR VISITOR´S VISA

You need to apply for E-visa to Kenya at least 5 business days prior to departure using <https://evisa.go.ke/> but we recommend that you apply earlier.

4. VACCINATIONS

Please check your routine vaccinations, such as diphtheria-tetanus-pertussis vaccine (difteristelkramp- kikhosta) or flue vaccination. Typically vaccinate against Yellow Fever, Hepatit A. Malaria tablets (Malarone) are recommended. A dose of Dukoral is recommended. Do not travel if you feel sick.



WHAT WE WILL DO:

1. HOTEL

We will organize with suitable business hotels in Mombasa which are appropriate for our visit and visitors.

2. PROGRAM

We are organizing a time table and site visits for the investor trip.

3. FOOD

Depending on the dietary restrictions and general wishes from our travelers, we will organize all lunches and dinners.

4. LOCAL TRANSPORTATION

We will organize all local transportation, such as visiting Techbridge or other places. This does not include personal excursions or airport transportation.

Please note that all costs are to be borne by the participants.
