SeaTwirl's unique floating vertical-axis wind turbine has a low centre of gravity, a slim substructure, and a generator house accessible at the sea surface enabling small, cost efficient, and locally available vessels to maintain it. SeaTwirl's first prototype, a unit of 30 kW is installed in the water outside off Lysekil and has verified the design in marine environment. Development is now ongoing for larger floating wind turbines for different applications and sites. The company is listed on Nasdaq First North Growth Market since 2016.
